

## Fuel Up Liability Waiver and Photo Release 2022-2023

## APPROVAL TO BE IN PERRY HARRISON SCHOOL

Fuel Up volunteers who volunteer time at Perry Harrison School need to have applied to be a Level 1 volunteer for Chatham County Schools for the 2020-2021 school year. Approval is required before entering the campus while students are present. Exceptions are only allowed for current employees and students of Perry Harrison School.

## PHOTO RELEASE

From time to time, Fuel Up will take pictures of volunteers to publicize and document our activities. The publication of the photographs will include but not limited to our newsletters, presentations for grants, annual reports, our website and posted on Fuel Up's Facebook page. We guarantee that names will not be included. You may decide to take back your authorization at any time in writing.

## LIABILITY WAIVER

Fuel Up aims to provide a safe, healthy and clean environment for our families, our volunteers and school personnel. Care should be taken to ensure that food items are sealed and not past their expiration date. Packaged food items should not be opened. Proper hygiene should be followed.

From time to time, heavy items will have to be moved. Carts are available. If you are unable to pick up the items, please inform the other volunteers so accommodations can be made. We recommend wearing closed-toe shoes. Please report accidents or injuries immediately. As a volunteer, you release and hold harmless Fuel Up from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my volunteer work.

Fuel Up follows all Chatham County Schools, NCDHHS and CDC guidelines as they pertain to Covid-19. As circumstances and understanding of COVID-19 evolve, so will public health and safety recommendations and requirements. As a result, this waiver may not include all current governmental or health expert requirements and recommendations.

*Fuel Up volunteers will stay at home if sick.* Please do not show up for your volunteer shift if you or your family member are sick or you have symptoms of Covid-19 within the last 14 days. If you happen to feel ill or develop a fever while volunteering, inform another individual and stop volunteer work immediately.

I expressly agree that this Waiver is intended to be as broad and inclusive as permitted by the laws of the State of North Carolina, and that this Waiver shall be governed by and interpreted in accordance with the laws of the State of North Carolina. I have reviewed this policy, understand it, and agree to it. Any volunteer under the age of eighteen years of age must have the consent of a parent or guardian prior to volunteering.

I affirm that I have permission to enter Perry Harrison School.

I grant Fuel Up all rights and titles for the initial and future use of photographs of me while volunteering and understand there will be no financial consideration for the use of the photographs.

I assume full responsibility with respect to personal health, bodily injury, personal injury, illness, or property damage that may result from my participation with Fuel Up.

I affirm that I, as well as all household members, do not currently have, nor have experienced the symptoms of Covid-19 WITHIN THE LAST 14 DAYS and have not been diagnosed with COVID-19 WITHIN THE PAST 30 DAYS.

I affirm that I, as well as all household members, have not knowingly been exposed to anyone diagnosed with COVID-19 WITHIN THE PAST 30 DAYS.

I understand that Fuel Up cannot be held liable for any exposure to the COVID-19 virus.
